Adoption of the Interconnection Agreement

This Adoption of the Interconnection Agreement ("Agreement") is entered into by and between Citizens Telephone Company of Higginsville, Missouri ("Citizens") and Time Warner Cable Information Services (Missouri) LLC ("CLEC"), each of which may be referred to herein as a "Party," or collectively as "the Parties," to establish the terms, conditions and rates for local interconnection and the exchange of local traffic for the State of Missouri.

Now Therefore, the Parties agree as follows:

1. ADOPTED AGREEMENT

- 1.1 This Agreement between the Parties shall consist of the Interconnection Agreement entered into by and between Citizens and Charter Fiberlink -Missouri, LLC that was approved by the Missouri Public Service Commission as an Interconnection Agreement for the State of Missouri ("Adopted Agreement") effective on December 16, 2021, in File Number IK-2022-0108, attached hereto as **Attachment A**.
- 1.2 This Agreement is made a part of and incorporates the terms and conditions of the Adopted Agreement, including all amendments to that Adopted Agreement (the "Terms").
- 1.3 Except as set forth herein, the Adopted Agreement remains unchanged and in full force and effect.

2. PARTY

For the purposes of this Agreement, Time Warner Cable Information Services (Missouri) LLC, or CLEC is hereby substituted in the Adopted Agreement for "Charter Fiberlink - Missouri, LLC."

3. Provisions

- 3.1 The Terms of the Adopted Agreement are being adopted in their entirety by CLEC pursuant to CLEC's statutory rights under Section 252(i). The filing and performance by Citizens of the Terms do not in any way constitute a waiver by Citizens of any position as to the Terms or a portion thereof, nor constitute a waiver by Citizens of any or all rights and remedies it may have to seek review of the Terms, or to seek review in any way of any provisions included in these Terms as a result of CLEC's 252(i) election.
- 3.2 Should CLEC attempt to apply the adopted Terms in a manner that conflicts with the provisions set forth herein, Citizens reserves its rights to seek appropriate legal and/or equitable relief.

3.3 CLEC represents that it is complying with all provisions of the Adopted Agreement as of the effective date of the adoption.

4. EFFECTIVE DATE AND TERM

4.1 This Agreement shall become effective on the date of Commission Approval ("Effective Date"); however, the Parties may agree to implement the provisions of this Agreement upon execution by both Parties.

5. REGULATORY REQUIREMENTS

- 6.1 CLEC represents and warrants that it is authorized to provide telecommunications services in the State of Missouri.
- 6.2 The Parties will cooperate to file this Agreement with the Commission for approval and complete all attendant requirements of the Commission for such approval.
