MOTION TO MODIFY PROCEDURAL SCHEDULE

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and hereby moves the Missouri Public Service Commission (Commission) to modify the Procedural Schedule adopted in the above-captioned matter, stating:

1. Lena Mantle will serve as a primary witness for Staff in the hearing currently scheduled for June 14 – 15, 2012. However, since establishing the procedural schedule in this case, Ms. Mantle has been designated to represent the Commission in Moldova on June 8-16, 2012, in connection with the NARUC-facilitated partnership between the Commission and the Moldovan National Agency for Energy Regulation.

2. Staff notified the other parties in this matter of Ms. Mantle's conflict and solicited their input for addressing it. Staff is now proposing the hearing be rescheduled to June 21 – 22, 2012.

3. Counsel for Union Electric Company, Office of the Public Counsel, Barnes-Jewish Hospital, and Missouri Industrial Energy Consumers have notified Staff counsel they do not object to the proposed change.

4. To accommodate this change, Staff also proposes that the briefing dates be rescheduled one week later as well, resulting in a new procedural schedule as follows:
