1. On January 21, 2015 (effective February 20, 2015), the Commission issued its Order Approving Application. Among other things, the Order directed as follows:

Kimberling City Water Company, Upper White River Basin Foundation, Inc., or Ozarks Clean Water Company shall submit notice to the Commission regarding evidence of the transfer of assets to Upper White River Basin Foundation, and the subsequent transfer to Ozarks Clear Water Company within five days after the transfer to Ozarks Clean Water Company.

- 2. The transfers that were the subject of this case were completed on February 20, 2015. On that date, the former KCWC assets were transferred to Upper White River Basin Foundation, Inc. and then, subsequently, transferred to Ozarks Clean Water Company.
 - 3. The Commission's Order further stated that:

Upon receipt of the notice of transfer to Ozarks Clean Water Company, the certificate of convenience and necessity and the tariff on file for Kimberly City Water Company shall be cancelled.

4. Accordingly, KCWC hereby moves the Commission to cancel KCWC's certificate and tariff.

WHEREFORE, KCWC respectfully requests that the Commission consider this notice and, thereafter, issue its order cancelling KCWC's certificate and tariff.
