ORDER GRANTING MOTION TO SET PREHEARING CONFERENCE

On March 6, 2012¹, John Maggard filed an application with the Missouri Public Service Commission requesting that his electric supplier be changed from Kansas City Power & Light Company ("KCP&L") to SAC Osage Electric Cooperative, Inc., ("SAC Osage").² The Staff of the Commission suggested mediation, which the parties attempted. On June 1, Mr. Maggard filed a notice in the case stating that he rejects GMO's offer.

The Commission finds that a prehearing conference is now appropriate. The parties or their attorneys shall appear in person, or by telephone, at the conference. They shall be prepared to discuss the nature of any discovery each will conduct, the time necessary to complete discovery, and to prepare for hearing. Also, the parties shall be prepared to discuss the stipulation of facts not at issue. The parties will also be encouraged to discuss settlement.

If the parties do not resolve their dispute, they shall prepare and file a joint proposed procedural schedule or, in the event the parties cannot agree on a procedural schedule, each party shall file its own proposed schedule.

THE COMMISSION ORDERS THAT:

1. A prehearing conference is scheduled for June 14, 2012, at 10:00 a.m., at the Commission's office at the Governor Office Building, 200 Madison Street, Jefferson City, Missouri, Room 305. This building meets accessibility standards required by the Americans with Disabilities Act.
