## CERTIFICATION TO PROVIDE BASIC LOCAL TELECOMMUNICATIONS SERVICES

On March 11, 2024, Time Warner Cable Information Services (Missouri) LLC (TWCIS), pursuant to Section 392.550, RSMo, filed an application for registration to provide Basic Local Exchange (CLEC) Telecommunications Services in the following exchanges:

Higginsville

The Commission has reviewed the application and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo. The affidavit attached to the application represents that the company has not had contact with the office of the Commission about any substantive issue connected to the filing within 150 days before filing the application. On the basis of that representation, for good cause shown, the Commission will waive application of the pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1).

This order will be issued with less than a 30-day effective date to comply with Section 392.550, RSMo.

1. Time Warner Cable Information Services (Missouri) LLC is registered to provide CLEC Telecommunications Services in the exchanges set forth in the affidavit attached to the application and restated above.
2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-4.017(1) are waived.
3. This order shall become effective on April 1, 2024.
4. This file may be closed on April 2, 2024.
