This case was held in abeyance while Evergy Metro, Inc. d/b/a Evergy Missouri Metro and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (collectively "Evergy") pursued securitization of these same costs through the issuance of Securitized Utility Tariff Bonds in File No. EF-2022-0155. The Commission granted Evergy Missouri West's request to securitize those costs and the Securitized Utility Tariff Bonds have since been issued.

On March 13, 2024, Evergy filed a motion to dismiss this case. Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to any pleading unless another response time is established by the Commission. No party filed a response to Evergy's motion. Therefore, the Commission will grant Evergy's motion and dismiss this case.

- 1. The *Motion to Dismiss* filed by Evergy on March 13, 2024, is granted.
- 2. This order shall be effective May 4, 2024.
