# ORDER AMENDING PROCEDURAL SCHEDULE

Issue Date: August 1, 2018 Effective Date: August 1, 2018

On June 4, 2018, Union Electric Company d/b/a Ameren Missouri (Ameren Missouri) applied to the Commission for approval of a Missouri Energy Efficiency Investment Act (MEEIA) plan. Notice was given and numerous interventions were granted. A procedural conference was held on June 19, 2018. Following the conference, Ameren Missouri, the Staff of the Missouri Public Service Commission (Staff), the Office of the Public Counsel, the Missouri Department of Economic Development – Division of Energy, Renew Missouri Advocates d/b/a Renew Missouri, the National Housing Trust, Tower Grove Neighborhoods Community Development Corporation, and Consumers Council, jointly filed a proposed procedural schedule. The Commission adopted the proposed procedural schedule on June 27, 2018.

On July 23, 2018, Staff filed a motion requesting that the procedural schedule be suspended. The Commission set a deadline of August 2, 2018, for the filing of responses to the motion. On July 26, 2018, Staff and Ameren Missouri filed a joint motion to modify the current procedural schedule in lieu of Staff's motion to suspend. Staff and Ameren asked that the Commission expedite approval of their motion to accommodate the new proposed procedural schedule. The Commission directed that responses to the request for an amended procedural schedule be filed no later than

July 30, 2018. No responses were received. The Commission will amend the procedural schedule as set out below.<sup>1</sup>
