# INTERCONNECTED VOICE OVER INTERNET PROTOCOL REGISTRATION

On April 18, 2024, TWC IP Enabled Services, LLC, pursuant to Section 392.550, RSMo, filed an application for registration to provide Interconnected Voice over Internet Protocol services (IVoIP) in the following exchanges in the state of Missouri:

Company proposes to offer interconnected VoIP service in the same geographical footprint as Time Warner Cable Information Services (Missouri), LLC

The Commission has reviewed the application and finds that it and the attached affidavit comply with the filing requirements set forth in Section 392.550, RSMo. 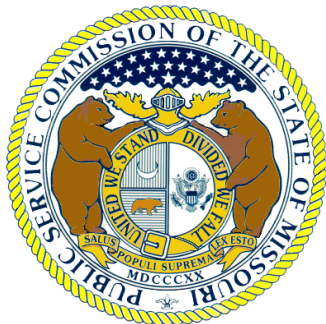
