Re: Interconnection Agreement Adoption (Case No. IK-2024-0227)

Dear Judge Dippell:

On February 7, 2024, we filed a letter with the Commission requesting approval of an Adoption Agreement that had been signed by Citizens Telephone Company of Higginsville, Missouri, and Time Warner Cable Information Services (Missouri), LLC. The purpose of the Adoption Agreement was to allow Time Warner Cable Information Services (Missouri), LLC to adopt the existing Interconnection Agreement between Citizens Telephone Company of Higginsville, Missouri, and Charter Fiberlink-Missouri, LLC, which the Commission previously approved in Case No. IK-2022-0108. On March 28, 2024, the Commission issued its Order Approving Adoption of Interconnection Agreement.

Upon review, it was noted that the signature line on the Adoption Agreement contains an erroneous company name of "Time Warner Communication (Missouri), LLC." As a result, we have caused the Adoption Agreement to be re-executed with the correct name of the signatory party, i.e., Time Warner Cable Information Services (Missouri), LLC. A copy of the Revised Adoption of the Interconnect Agreement is attached to this letter. Accordingly, we would request that the Commission issue an amended or new Order Approving the Revised Adoption of the Interconnection Agreement, and for such other orders as may be appropriate in the circumstances.

We also request waiver of Rule 20 CSR 4240-4.017(1)(D) for good cause. By signing this letter, I hereby certify that neither I, nor any other member of the filing parties, has had communications with the Commission, Commission Advisor, Regulatory Law Judge, or any member of their support team in the one-hundred fifty (150) days prior to the filing date of this letter regarding any substantive issue included in this filing.
