ORDER GRANTING CERTIFICATE TO PROVIDE TELECOMMUNICATIONS SERVICE

On May 30, 2024, Ideatek Telcom, LLC, filed an application for authorization to provide basic local exchange (CLEC) and non-switched local telecommunications (IXC) services statewide in the State of Missouri, as permitted by Sections 392.611.4 and 392.550, RSMo (2016).

The Commission has reviewed the application filed by Ideatek Telcom, LLC and finds that it and its attached affidavit comply with the filing requirements set forth in Section 392.550.

The affidavit also represents that the company has not had contact with the office of the Commission about any substantive issue connected to the filing within 150 days prior to the filing date of the application.

Pursuant to Section 392.550.3, this order shall be effective in less than thirty days.

THE COMMISSION ORDERS THAT:

1. Ideatek Telcom, LLC is granted authority to provide basic local exchange and non-switched local telecommunications services statewide.
2. The pre-filing notice requirements of Commission Rule 20 CSR 4240-

4.017(1) are waived.

3. This order shall become effective on June 14, 2024.
4. This file shall close on June 15, 2024.

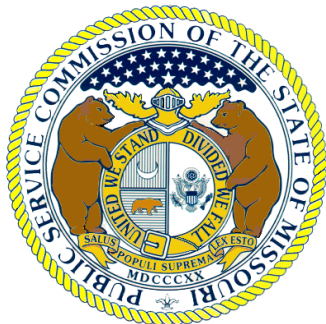
