## ORDER DIRECTING RESPONSES TO COMPLIANCE TARIFF

Issue Date: July 8, 2024

Effective Date: July 8, 2024

On January 2, 2024,<sup>1</sup> United Services, Inc. (United Services) filed a notice requesting an increase in its annual overall operating revenues in a staff assisted sewer rate case. On July 1, Staff and United Services filed a disposition agreement resolving all issues. On July 3, United Services filed a tariff sheet purporting to comply with the pending disposition agreement. The tariff, assigned Tracking No. JS-2025-0005, carries an effective date of September 1.<sup>2</sup>

The Commission will direct the Staff of the Commission (Staff) to file its recommendation as to whether the tariff complies with the disposition agreement.

### THE COMMISSION ORDERS THAT:

1. On or before July 29, 2024, Staff shall file a recommendation as directed in the body of this order.
2. Any other party wishing to file a recommendation regarding United Services' compliance tariff shall do so on or before July 29, 2024.
3. This order shall be effective when issued.
