ORDER CANCELING CERTIFICATES OF SERVICE AUTHORITY

Issue Date: July 16, 2024

Effective Date: August 15, 2024

On July 8, 2024,¹ IRU Networks, LLC filed notice that control of IRU Networks has been transferred to USA Digital Communications, Inc. On July 15, IRU Networks filed a supplemental notification requesting to cancel its telecommunications registrations from the State of Missouri. IRU Networks stated that there are no customers whose service would be impacted and it is not currently marketing its services.

IRU Networks is certificated to provide interexchange and competitive local exchange telecommunications services. The Commission authorized it to provide basic local exchange telecommunications services in File No. CA-2017-0302, and to provide interexchange services in File No. XA-2017-0301. IRU Networks has one currently effective tariff, Tracking No. YX-2017-0243.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo (2016), which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission ... upon application of the person or company affected.”

Based on the request of IRU Networks, the Commission finds that the certificates of service authority granted to IRU Networks shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of service authority issued to IRU Networks, LLC in the state of Missouri to provide basic local exchange telecommunications services, as authorized in File No. CA-2017-0302, and to provide interexchange services, as authorized in File No. XA-2017-0301, is canceled.
2. IRU Networks, LLC's tariff assigned Tracking No. YX-2017-0243 is canceled.
3. This order shall be effective August 15, 2024.
4. This file shall close August 16, 2024.
