AMENDED NOTICE OF INTENDED CASE FILING

COMES NOW, Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“Evergy Missouri West”) and pursuant to 20 CSR 4240-4.017(1), gives notice that it intends to file an application for certificates of public convenience and necessity (“CCN”), pursuant to Section 393.170 RSMo. and 20 CSR 4240-20.045, and states as follows:

1. 20 CSR 4240-20.045 contains the requirements for filing for CCNs for electrical production facilities.
2. The issues likely to be before the Missouri Public Service Commission (“Commission”) in this case may be any issue related whether the requested solar generation is necessary or convenient to the public service.
3. The Company also plans to file a new tariff and testimony at the same time of the CCN regarding a proposed subscription-based renewable energy program which will sell renewable energy credits from the solar generation to interested customers. There may be issues related to the proposed tariff. Since this tariff relates to the underlying CCN filing, the interests of judicial economy are advanced by including the additional information in the CCN filing.
4. Regarding the requirement in Rule 4.017(1) that a 60-day notice of filing include “a summary of all communications regarding substantive issues likely to be in the case between the filing party and the office of the commission that occurred in the ninety (90) days prior to the filing of the notice”, the Company verifies that Evergy Missouri West has had no communications

with the Office of the Commission (as defined in 20 CSR 4240-4.015(10)) respecting this filing during the 90 days prior to filing this notice.

5. Every Missouri West may seek a waiver of this Amended Notice requirement when it files its CCN application.
