Staff states in its motion that NewDawn contacted Staff via letter stating NewDawn was no longer providing service in Missouri and requesting the Commission cancel NewDawn's certificate of service authority and interconnected voice over internet protocol registration. Staff recommends that the Commission cancel the company's certificate of service authority to provide intrastate interexchange, competitive local exchange telecommunications services, and interconnected voice over internet protocol services.

On August 29, 2019, the Commission issued an Order Establishing Time to Respond allowing parties until September 9, 2019, to file an objection or request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion, the Commission finds that the certificate of service authority and registration granted to NewDawn Fiber, shall be canceled.

THE COMMISSION ORDERS THAT:

1. The certificate of authority to provide interexchange and competitive local exchange telecommunications services granted to NewDawn Fiber, in File Number TA-2018-0300, is canceled.
2. The registration to provide Interconnected Voice over Internet Protocol services granted to NewDawn Fiber, in File Number TA-2018-0300, is canceled.
3. This order shall become effective on October 11, 2019.
4. This case may be closed on October 12, 2019.
