## MOTION TO RESCHEDULE PREHEARING CONFERENCE

COMES NOW Ozark Energy Partners, LLC ("Ozark" or "Applicant"), and moves the Commission to cancel the prehearing conference currently scheduled in this case for October 19, 2006, and to reschedule that prehearing conference on Thursday, November 16, 2006. In support of its motion, Ozark states as follows:

- 1. Ozark is continuing to develop the additional information that is required in order to complete its Application in this case. The consulting firm of Cattron Enterprises, Inc. is now working with Ozark to that end.
- 2. Two elections are scheduled in the proposed service area on November 7, 2006, that will affect the instant Application. On that date, the citizens of Kimberling City and Highlandville, Missouri, will be voting on whether to approve the cities' franchises to Ozark Energy Partners, LLC. Approval of Ozark's franchises in those elections will significantly advance the Application in this case, and make the prehearing conference herein more fruitful.
- 3. For these reasons, Ozark proposes that the prehearing conference be rescheduled for Thursday, November 16, 2006.
- 4. Counsel for the all other Parties; namely, Staff, the Office of the Public Counsel, and Intervenors Alliance, MGE, and Southern Star Central Gas Pipeline,

have been advised of Ozark's intention to file this Motion. All have indicated that they do not object to rescheduling the Prehearing conference.

WHEREFORE, Ozark Energy Partners, LLC respectfully requests that the Commission issue an Order canceling the prehearing conference currently scheduled in this case on Thursday, October 19, 2006, and schedule, in its stead, a prehearing conference on Thursday, November 16, 2006, beginning at 10:00 a.m. at the Commission's offices.
