ORDER DIRECTING STAFF TO FILE A RECOMMENDATION AND SETTING TIME FOR RESPONSES

On September 13, 2024, the Commission directed its Staff (Staff) to file a pleading indicating when Staff could file a recommendation about MRG Utilities' applications for certificates of convenience and necessity (CCN). Staff states that it can file a recommendation by January 6, 2025.

The Commission will order its Staff to file a recommendation regarding MRG Utilities applications, and shall set a time for any responses.

THE COMMISSION ORDERS THAT:

1. Staff shall file its recommendation regarding MRG Utilities' CCN applications no later than January 6, 2025.
2. Any responses to Staff's recommendation or MRG Utilities' CCN applications shall be filed no later than January 13, 2025.

3. This order is effective when issued.
