## ORDER ESTABLISHING TIME TO RESPOND

On October 3, 2019, the Staff of the Public Service Commission filed a motion requesting that the Commission cancel Local Access, LLC's certificates of service authority. The Commission granted Local Access certificates of service authority to provide interexchange and basic local telecommunications services on June 6, 2013, in File Number LA-2013-0482.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup> Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificates based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.

#### THE COMMISSION ORDERS THAT:

1. Anyone wishing to respond to Staff's Motion or request a hearing shall do so by filing a pleading no later than October 15, 2019, with:
