## ORDER CANCELING IVOIP REGISTRATION

Issue Date: October 21, 2019

Effective Date: October 31, 2019

On October 3, 2019, the Staff of the Missouri Public Service Commission filed a motion asking the Commission to cancel the IVoIP Registration of Blue Atlas, LLC d/b/a EZ Tel. The Commission granted EZ Tel that Registration in File No. DA-2017-0133, on November 16, 2016.

Staff states in its motion that EZ Tel sent a letter to Staff on September 12, 2019, indicating its desire to relinquish its Registration. Staff indicates EZ Tel's request to cancel its Registration is in compliance with Commission Rule 20 CSR 4240-28.011(3), and asks the Commission to cancel that Registration.

On October 4, 2019, the Commission issued an Order Establishing Time to Respond, allowing parties until October 15, 2019, to object or to request a hearing. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a Registration pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on the company's request, and Staff's motion, the Commission finds that the Registration granted to EZ Tel shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The Registration to provide IVolP services granted to Blue Atlas, LLC, d/b/a EZ Tel in File Number DA-2017-0133, is canceled.
2. This order shall become effective on October 31, 2019.
3. This file may be closed on November 1, 2019.
