ORDER ACKNOWLEDGING APPROVAL OF THE REVISED ADOPTION OF THE INTERCONNECTION AGREEMENT

This order acknowledges the approval of the Revised Adoption of the Interconnection Agreement between Citizens Telephone Company of Higginsville Missouri (Citizens) and Charter Fiberlink-Missouri, LLC by Time Warner Cable Information Services (Missouri) LLC d/b/a Time Warner Cable.

On February 7, 2024, Citizens filed an application with the Commission for approval of its Adoption of the Interconnection Agreement (the "Adoption Agreement") with Time Warner Cable Information Services (Missouri) d/b/a Time Warner Cable under the provisions of the Federal Telecommunications Act of 1996 (the Act).

On March 20, 2024, the Commission issued an Order Approving Adoption of Interconnection Agreement. On May 23, 2024, Citizens filed a Revised Adoption of the Interconnection Agreement based on an erroneous company name in the signature line on the Adoption Agreement.

On May 24, 2024, the Commission issued an Order Setting Time for Responses to allow parties wishing to respond to Citizens Revised Adoption of the Interconnection Agreement a chance to do so no later than June 3, 2024. No responses were received. The Telecommunications Act at 47 U.S.C. § 252(e)(4) states that the adoption of an

interconnection agreement is deemed approved if the state commission does not act to approve or reject it within 90 days. For clarification, the Commission is issuing this order acknowledging that the interconnection agreement as amended is approved.

THE COMMISSION ORDERS THAT:

1. The Revised Adoption of the Interconnection Agreement between Citizens and Time Warner Cable, filed on May 23, 2024, is approved.
2. This order shall be effective when issued.
3. This file may be closed.
