ORDER GRANTING EXTENSION OF TIME

On September 13, 2019, Missouri-American Water Company (Missouri-American) filed an application with the Missouri Public Service Commission (Commission) seeking a Certificate of Convenience and Necessity to install, own, acquire, construct, operate, control, manage and maintain a sewer system in Jefferson County, Missouri, in a subdivision known as Harbor View Estates.

Thereafter, the Commission ordered the Staff of the Commission (Staff) to file a recommendation or a request for additional time. Staff timely filed its request for additional time on October 31. Staff states it needs additional time to conduct its investigation, obtain replies to data requests, and continue further discussion. Staff states that Missouri-American does not oppose its request for additional time.

The Commission finds that the request for additional time is reasonable and will grant it.

THE COMMISSION ORDERS THAT:

1. The *Request for Additional Time to File a Recommendation* filed by the Staff of the Commission on October 31, 2019, is granted.

2. The Staff of the Commission shall submit its recommendation no later than December 2, 2019.

3. This order shall be effective when issued.


