**ORDER FURTHER STAYING PROCEEDINGS
AND ORDERING STATUS REPORT**

Summit Natural Gas of Missouri, Inc. ("SNGMo") has applied for approval of its Cost Allocation Manual ("CAM") for transactions involving the purchase of goods or services from an affiliated entity. On August 26, 2019, SNGMo and the Staff of the Missouri Public Service Commission ("Staff") jointly filed a motion asking the Commission to stay these proceedings due to the pendency of File Number AW-2018-0394, which will likely impact the rules applicable to affiliate transactions and CAMs. The Commission granted the request to stay the proceedings, and also requested a status report.

The status report indicates that procedural schedules are being discussed in File Number AW-2018-0394, and at least one party has proposed a schedule that reaches to the end of February 2020.

Based on this potential timeline, the Commission will continue the stay placed on these proceedings and will order a further status report.

THE COMMISSION ORDERS THAT:

1. The stay of proceedings granted in this case will continue.
2. The parties shall file a status report no later than March 2, 2020.

3. This order shall be effective when issued.


