On October 8, 2024, the Staff of the Commission (Staff) filed a *Motion to Cancel Certificate of Service Authority*. Fore Street Telecom, LLC failed to submit an annual report to the Missouri Commission for calendar years 2022 and 2023. The requirement of a telecommunications company to file an annual report is identified in Sections 392.210 and 392.390, RSMo, and 20 CSR 4240-28.012(1)(A). The Commission previously granted Fore Street Telecom, LLC registration in File No. DA-2017-0014 on July 23, 2016.

The Commission will establish a time for interested parties to file an objection or request a hearing. If no objection is filed, the certificate may be canceled.
