On June 4, 2019, Union Electric Company d/b/a Ameren Missouri filed notice, pursuant to Commission Rule 20 CSR 4240-4.017(1), indicating its intent to file an application with the Missouri Public Service Commission for a waiver from certain meter testing requirements. The Commission's rule provides that if the application is not filed within 180 days, the noticed case shall close.


