NOTICE OF NEW FILE NUMBER

Issue Date: December 3, 2019

On June 4, 2019, Liberty Utilities (Missouri Water) LLC, d/b/a Liberty Utilities (Liberty Utilities) and The Empire District Electric Company (Empire) jointly filed notice, pursuant to Commission Rule 20 CSR 4240-4.017(1), indicating their intent to file an application with the Missouri Public Service Commission for approval of the transfer of the water assets of Empire to Liberty Utilities. That filing was assigned File No. WM-2019-0379. The Commission's rule provides that if the application is not filed within 180 days, the noticed case shall close. The 180 day period expired on December 1, 2019, and on December 3, the Commission issued notice that File No. WM-2019-0379 was closed.

After that notice was issued, on December 3, Liberty Utilities and Empire filed a *Second Notice of Intended Case Filing* in File No. WM-2019-0379, indicating they planned to file their application within the next sixty days, and asking that the file remain open. Rather than reopen File No. WM-2019-0379, the Commission has assigned a new file

number, WM-2020-0156, to the *Second Notice of Intended Case Filing*. When Liberty Utilities and Empire file their application, they should do so in File No. WM-2020-0156.


