ORDER CANCELLING CERTIFICATE OF SERVICE AUTHORITY AND TARIFF

On December 2, 2019, the Staff of the Missouri Public Service Commission (Staff) filed a motion requesting that the Commission cancel the certificate of interexchange service authority and applicable tariff of Frontier Communications of America, Inc. (Company) in the State of Missouri. The Commission previously granted the Company a certificate to provide intrastate interexchange service in Case No. TA-2001-692. The Company has an applicable tariff, No. JX-2003-1864. The Staff's motion states that the Company wishes to voluntarily relinquish its authority and cancel any applicable tariffs.

On December 2, 2019, the Commission issued its order that anyone wishing to respond to Staff's Motion or request a hearing do so by filing a pleading no later than December 12, 2019. There were no such filings. The Commission need not hold a hearing if, after proper notice and opportunity to
