## ORDER RELIEVING STAFF FROM FILING A PLEADING

Issue Date: November 4, 2024

Effective Date: November 4, 2024

On October 16, 2024, Complainant, Christopher V. Modzeleski, filed a complaint with the Commission against Spire Missouri, Inc. d/b/a Spire. The Commission directed its Staff (Staff) to file a pleading not later than November 4, 2024, stating when it could file a report on this complaint.

On October 31, 2024, Spire filed a *Notice of Satisfaction* stating that it had resolved Complainant's issues and that Complainant was satisfied with the result.

On November 4, 2024, Staff filed a pleading asking the Commission to suspend its order directing Staff to file a pleading stating when it can file a report. Staff also suggested that the Commission order Complainant to respond to Spire's Notice of Satisfaction.

The Commission will not order Complainant to respond to Spire's *Notice of Satisfaction*. Commission Rule 20 CSR 4240-2.080(13) allows parties ten days to respond to any pleading unless another response time is established by the Commission. Complainant has sufficient time to let the Commission know if his complaint has not been satisfied.

The Commission will relieve Staff of having to file a pleading stating when it can file a report.

**THE COMMISSION ORDERS THAT:**

1. Staff is relieved from filing a pleading on November 4, 2024 stating when it can file a report about this complaint.
2. This order is effective when issued.
