## ORDER CANCELING REGISTRATION

Issue Date: November 14, 2024

Effective Date: November 24, 2024

On October 29, 2024, Charter Advanced Services (MO), LLC filed a Withdrawal of Registration seeking to cancel its registration to provide Interconnected Voice over Internet Protocol service (“IVoIP”) in the State of Missouri. The Commission granted Charter Advanced Services (MO), LLC its IVoIP registration in the State of Missouri in File No. DA-2013-0365.

The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup>

Based on Charter Advanced Services (MO), LLC’s request, the Commission finds that the IVoIP registration granted to Charter Advanced Services (MO), LLC shall be canceled.

### IT IS ORDERED THAT:

1. The registration to provide Interconnected Voice over Internet Protocol services, granted to Charter Advanced Services (MO), LLC in File Number DA-2013-0365, is canceled.
2. This order shall become effective on November 24, 2024.
