TIME TO RESPOND TO MOTION**

On December 19, 2019, the Staff of the Missouri Public Service Commission filed a motion requesting that the certificate of interexchange service authority and applicable tariff of Impact Telecom, Inc. (Company) be cancelled at the company's request. On April 25, 2010, the Commission had granted the company a certificate to provide interexchange telecommunication service in Case Number XA-2012-0295. The Company has an applicable tariff, Tariff No. YX-2012-0510.

The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate and applicable tariff based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to file a motion for hearing.
