## ORDER SETTING LOCAL PUBLIC HEARINGS

Issue Date: November 19, 2024

Effective Date: November 19, 2024

On November 15, 2024,<sup>1</sup> the Ameren Transmission Company of Illinois (ATXI) filed a *Motion Requesting Local Public Hearings and for Expedited Treatment* requesting a local public hearing be scheduled on December 9 and 10 and that an order be issued by November 20 in order to allow adequate time to notify customers. That same day, the Regulatory Law Judge shortened the response time for objections to the request to November 19. No parties responded to the *Motion*.

The Commission will schedule a local public hearing for December 9, 2024 in-person and hold a virtual local public hearing via video and telephone conference on December 10, 2024, and will direct written comments be submitted to the Commission's Electronic Filing and Information System (EFIS).

### THE COMMISSION ORDERS THAT:

1. An **in-person** local public hearing shall be held at **1109 South Birch, Albany, Missouri 64402** to begin at **6 p.m.** on **December 9, 2024**.

2. A virtual local public hearing is scheduled to begin at **12 p.m.** on **December 10, 2024**, via the internet-based video and teleconferencing service, WebEx.

a. To attend the virtual local public hearing **by telephone**, at the time of the hearing call toll free 1-650-479-3207, listen to the prompt and enter the meeting number/access code 2635 928 5519, followed by # (pound/hashtag symbol). If prompted for a password, enter 0302.

b. To attend a virtual local public hearing **by video/internet** visit the website at [www.webex.com](http://www.webex.com) or download the Cisco WebEx Meetings application. At hearing time, enter the meeting number/access code 2635 928 5519 and password 0302.

3. The public hearing will begin with a question-and-answer session and formal public comments to the Commission will begin immediately following the conclusion of the question-and-answer session.

4. The Commission's Public Policy and Outreach Department shall make an informal presentation and conduct a question-and-answer session for the public at the beginning of the local public hearing.

6. Written comments may be submitted to the Commission in writing by mailing the comment to the Missouri Public Service Commission, P.O.
