Please accept attached Notice of Internal Corporate Reorganization submitted on behalf of VoIP Innovations, LLC ("VoIP Innovations"). VoIP Innovations and its parent company, Sangoma US Inc. ("Sangoma US") expected to be consummated on January 1, 2025, whereby VoIP Innovations will be consolidated into Sangoma US.

VoIP Innovations is ceasing to exist as a VoIP provider and respectfully requests the cancellation of its authority as granted in DN-2024-0293 effective January 1, 2025.

The internal corporate reorganization does not reflect a transfer of control, because there will be no change in ownership or management of the company serving VoIP Innovations customers.

Star2Star Communications, LLC (“Star2Star”), VoIP Innovations, LLC (“VoIP Innovations”) and the parent company, Sangoma US Inc. (“Sangoma US”) (collectively, the “Parties”), notify the Commission of the internal reorganization expected to be consummated on January 1, 2025, whereby Star2Star and VoIP Innovations will be consolidated into Sangoma US.

Star2Star and VoIP Innovations will no longer operate within the state of Missouri and therefore request the Commission to cancel the Authority of Star2Star and VoIP Innovations.

A description of the transaction is set forth below.

I. DESCRIPTION OF THE PARTIES

Star2Star Communications, LLC is a limited liability company organized under the laws of the state of Delaware in 2004. Star2Star’s principal business address is 301 N. Cattlemen Road, Suite 300, Sarasota, FL 34232. Star2Star registered with the Missouri Public Service Commission to provide VoIP services on April 5, 2018, Docket Number DA-2018-0246.

VoIP Innovations, LLC is a limited liability company organized under the laws of the state of Delaware in 2019. VoIP Innovations’s principal business address is One Penn Center West Drive, Suite 400, Pittsburgh PA 15276. VoIP Innovations registered with the Missouri Public Service Commission to provide VoIP services on May 18, 2024, Docket Number DN-2024-0293.

Sangoma US Inc., is a corporation company organized under the laws of the state of Delaware. Sangoma US’s principal business address is 301 N. Cattlemen Road, Suite 300, Sarasota, FL 34232. Sangoma US is authorized to provide VoIP service in the state of Missouri in Docket Number DA-2017-0144 on December 12, 2016.

Sangoma US is the parent company of Star2Star and VoIP Innovations.

III. DESCRIPTION OF THE PROPOSED TRANSACTION

As part of an internal corporate reorganization, the [STATE] customers of Star2Star, VoIP Innovations and their parent, Sangoma US are undertaking a corporate reorganization expected to be consummated in late December 2024 with an effective date of January 1, 2025, whereby Star2Star and VoIP Innovations will be consolidated into Sangoma US. Following the reorganization, Star2Star and VoIP Innovations will no longer exist as separate legal entities and Star2Star and VoIP Innovations' existing customers will be served by Sangoma US. The corporate reorganization will not impact customers and service will continue under the current rates, terms, and conditions. Included as Exhibit A is a copy of the customer notice provided to customers of Star2Star and VoIP Innovations.

Upon completion of this reorganization, there will be no change to the management, corporate ownership, employees, rates, services, or other contract rights and obligations of the company serving Star2Star and VoIP Innovations customer base. All the current managerial, technical, and financial resources available to Star2Star and VoIP Innovations will remain available to Sangoma US. This corporate restructuring is in the public interest because it will allow Sangoma US to achieve administrative efficiencies and potential cost savings, thus financially strengthening the company without altering its operations in any respect.

Beginning January 1, 2025, Sangoma US Inc. will assume responsibility for all regulatory fees and assessments associated with Star2Star Communications, LLC and VoIP Innovations, LLC customers.

IV. CONCLUSION

Star2Star Communications, LLC and VoIP Innovations, LLC respectfully requests the Commission cancel the VoIP authorities for each of Star2Star Communications, LLC and VoIP Innovations, LLC, effective on January 1, 2025.

Customer Notice**

ADVISORY: VENDOR CHANGE DUE TO LEGAL MERGERS. On Dec. 31, 2024, Sangoma US Inc. will merge four of its subsidiary entities into Sangoma US Inc. The merging subsidiaries are: 1) Star2Star Communications, LLC; 2) VoIP Innovations, LLC; 3) Digium Inc., and 4) Digium Cloud Services. After the mergers, “Sangoma US Inc.” will be listed on all new invoices, statements, and other official documentation related to the merged entities. As a result of these mergers, no action is required from you. You will continue to receive the same products and services as you have in the past, but under the name of Sangoma US Inc. As of Jan. 1, 2025, a new W-9 will be provided to you for Sangoma US Inc. If you are tax-exempt, you must provide new exemption forms in the name of Sangoma US Inc. in order to maintain your tax-exempt status with Sangoma US Inc. Further instructions on providing the new forms will be provided in the coming weeks.
