The Commission opened this file to facilitate Staff's investigation of the City of New Florence's compliance with the Commission's gas safety rules. On December 27, 2019, Staff filed a progress report indicating New Florence has made progress in coming into full compliance with the gas safety rules. However, Staff explains there are still outstanding compliance concerns that New Florence is working with Staff to resolve. Staff proposes to file an additional progress report by March 31, 2020.

The Commission will direct Staff to file the additional progress report it proposes.
