On November 27, 2024, Ameren Missouri filed a Motion to Approve Program Templates and Incentive Ranges and Request for Expedited Treatment. On the same day, Ameren Missouri filed a Request to Approve Technical Resource Manual and Deemed Savings Table and Motion for Expedited Treatment. Ameren Missouri also filed Tariff Tracking No. JE-2025-0081.

The Motions for Expedited Treatment ask for approval of the above requests no later than December 15, 2024. The tariff bears an effective date of December 27, 2024.

The Commission will order responses.

1. The Staff of the Commission file a Recommendation or an alternative pleading no later than December 6, 2024.
