# STAFF'S RECOMMENDATIONS TO APPROVE TARIFF SHEETS

**COMES NOW** the Staff of the Missouri Public Service Commission and for its recommendations to approve tariff sheets on an expedited basis states:

- 1. On January 16, 2013, Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company filed tariff sheets they asserted comply with the Commission's January 9, 2013, *Report and Order* in these cases, as clarified on January 11, 2013.
- 2. When they filed tariff sheets on January 16, 2013, they also filed a motion requesting the Commission make them effective on January 26, 2013, asserting good cause exists to make them effective on less than the thirty days' notice required by § 393.140(11), RSMo, "because the Commission has already found that the Companies are presently in a revenue deficient position, and the Commission has already authorized the Companies to file the tariffs."
- 3. As it has opined in similar circumstances in other general rate cases, Staff agrees that the Commission's decisions on the rate increases and other changes authorized in its January 9, 2013, *Report and Order* in these cases, which it clarified on

January 11, 2013, constitute the § 393.140(11), RSMo, good cause required for purposes of allowing tariff sheets that implement them to go into effect on less than thirty days' notice. However, a Commission order that approves tariff sheets to go into effect on less than thirty days' notice must still allow time for "the public counsel or any corporation or person or public utility interested therein" to exercise the right § 386.500.1, RSMo, gives them to apply for a rehearing before the order takes effect.

- 4. In the attached Memoranda (Appendices A and B), the Missouri Public Service Commission Energy Rate Design & Tariffs Unit Staff (Staff) recommends that the Commission issue an Order that, for good cause shown, approves the proposed tariff sheets identified in the wherefore clause below, as filed on January 16, 2013, and substituted on January 18, to become effective on January 26, 2013, as Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company request.
- 5. Staff has verified that both Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company have filed their annual reports and are not delinquent on any assessment.
- 6. Staff is not aware of any other matter before the Commission that affects or is affected by these tariff sheet filings.

WHEREFORE, Staff requests the Commission issue an Order that finds (1) good cause shown to make them effective on less than thirty days' notice and (2) approves the following proposed tariff sheets, as filed on January 16, 2011, and substituted on January 18, 2013, to become effective on January 26, 2013, as Kansas City Power & Light Company and KCP&L Greater Missouri Operations Company request:

On January 9, 2013, the Missouri Public Service Commission ("Commission") issued its Report and Order ("Order") in Case No. ER-2012-0175, KCP&L Greater Missouri Operations Company's ("GMO") general electric rate increase request case. This Order approved an increase in GMO's overall Missouri jurisdictional gross annual electric revenues of \$48.9 million (\$26.2 million for its MPS rate district, and \$21.7 million for its L&P rate district).

GMO filed tariff sheets on January 16, 2013, it asserts comply with the Order. In an accompanying motion, GMO requested the Commission act on an expedited basis to approve the tariff sheets to become effective on January 26, 2013, which is less than the statutory standard 30-day period, but which is consistent with the end of the period for which the Commission suspended GMO's tariff filing that initiated this case. GMO filed substitute tariff sheets on January 18, 2013, to correct typos and to incorporate changes the Commission's Energy Rate Design & Tariffs Unit - Tariffs/Rate Design and Economic Analysis Sections and Energy Resource Analysis Unit Staff ("Staff") suggested to make the tariff sheets compliant with the Commission's Order.

Staff has reviewed the tariff sheets as GMO filed them on January 16, 2013, and as substituted on January 18, 2013, and is of the opinion that they comply with the Commission's Order. Staff is also of the opinion that good cause exists for the Commission to approve these tariff sheets on less than thirty days' because they comply with the Commission's Order. Therefore, Staff recommends the Commission approve the following tariff sheets as filed on January 16, 2013, and as substituted on January 18, 2013, to become effective on January 26, 2013, the requested effective date:
