ORDER DIRECTING NOTICE AND SETTING DEADLINES FOR INTERVENTION APPLICATIONS AND STAFF'S RECOMMENDATION

On December 13, 2024, Everyg Metro, Inc. d/b/a Everyg Missouri Metro and Everyg Missouri West, Inc. d/b/a Everyg Missouri West (collectively "Everyg"). applied for a depreciation authority order establishing a new depreciation rates to depreciate certain accounts. Everyg requests the Commission authorize depreciation rates for existing plant utility accounts that will be transferred to new plant utility accounts due to the implementation of Federal Energy Regulatory Commission (FERC) Order 898, which updates the Uniform System of Accounts (USOA) for certain categories of assets including solar and wind generation, energy storage, environmental credits and computer hardware, software and communications equipment.

The Commission will direct notice be given and set a deadline for intervention applications. The Commission will also direct Staff to file a recommendation.

THE COMMISSION ORDERS THAT:

1. The Commission's Data Center shall provide notice of this order and Everyg's application to the parties in File Nos. ER-2024-0189 and ER-2022-0129.

2. The Commission's Data Center shall provide notice of this order and Evergy's application to the county commissions in Evergy's service territory.

3. The Commission's Public Policy and Outreach Department shall provide notice of Evergy's application to news media serving residents of Evergy's service territory.

4. Applications for intervention shall be filed no later than January 13, 2025. Any such filing shall be submitted through the Commission's electronic filing and information system (EFIS) or delivered to:

5. No later than January 13, 2025, the Commission's Staff shall file either a recommendation regarding Evergy's application or a status report indicating when it expects to file a recommendation.

**APPLICATION OF EVERGY MISSOURI METRO AND EVERGY MISSOURI WEST
FOR A DEPRECIATION AUTHORITY ORDER**

Pursuant to Mo. Rev. Stat. 386.250 and 393.140¹and 20 CSR 4240-2.060, Evergy Metro, Inc. d/b/a Evergy Missouri Metro (“EMM”) and Evergy Missouri West, Inc. d/b/a Evergy Missouri West (“EMW”)(collectively, the “Company” or “Applicant”) hereby requests that the Missouri Public Service Commission (“Commission”) issue a Depreciation Authority Order (“DAO”) authorizing EMM and EMW to depreciate certain accounts with a specific depreciation rate.

1. EMM is a corporation duly organized and existing under the laws of the State of Missouri, with its principal office and place of business at 1200 Main Street, Kansas City, Missouri 64105. EMM is primarily engaged in the business of generating, transmitting, distributing, and selling electric energy in portions of eastern Kansas and western Missouri. EMM is an electric corporation and public utility as defined in Section 386.020 Mo. Rev. Stat. (2000), as amended. A Certificate of Good Standing was filed with the Commission in Case No. EN-2020-0063 and is incorporated herein by reference in accordance with 20 CSR 4240-2.060(1)(G). EMM is an electric corporation and public utility as defined in Section 386.020, Mo. Rev. Stat. (2010), as amended.

¹ Unless otherwise noted, all citations are to the Revised Statutes of Missouri (2010), as amended to date.

2. EMM holds Certificates of Convenience and Necessity from the Commission to transact business as an electric public utility in certain areas of the State of Missouri. In addition, EMM has heretofore filed with this Commission a certified copy of the Articles of Consolidation under which it was organized and of all amendments thereto.

3. EMM has no pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court that involve customer services or rates, which action, judgment, or decision has occurred within three years of the date of this application, except for:

- (i) *Marquette Lumumba Mugabe v. Evergy Missouri Metro*, File No. EC-2024-0289;
- (ii) *Shamera E. Williams v. Evergy Missouri Metro*, File No. EC-2025-0110; and
- (iii) *William Gregoric v. Evergy Missouri Metro*, File No. EC-2025-0143.

4. EMW is a Delaware corporation with its principal office and place of business at 1200 Main Street, Kansas City, Missouri 64105. It is engaged in the generation, transmission, distribution, and sale of electricity in western Missouri, including the suburban Kansas City metropolitan area, St. Joseph, and surrounding counties. EMW is an “electrical corporation” and a “public utility” subject to the jurisdiction, supervision, and control of the Commission under Chapters 386 and 393.

5. A certificate of authority for EMW to do business in Missouri as a foreign corporation was filed with the Commission in Case No. EN-2020-0064 and is incorporated by reference pursuant to 20 CSR 4240-2.060(1)(G).

6. EMW is a wholly owned subsidiary of Evergy, Inc. (“Evergy”). Evergy’s other wholly owned public utilities are Evergy Metro, Inc. (“Evergy Metro”) and Evergy Kansas Central, Inc. (“Evergy Kansas Central”). EMW has no annual report or regulatory assessment fees that are overdue.

7. EMW has no pending actions or final unsatisfied judgments or decisions against it from any state or federal agency or court that involve customer services or rates, which action, judgment, or decision has occurred within three years of the date of this application, except for:

(i) *Timothy Allegri, et al. v. Evergy Missouri West*, File No. EC-2024-0015.

The Company requests the authorization of depreciation rates for existing plant utility accounts that will be transferred to new plant utility accounts due to the implementation of FERC Order 898. In June 2023, FERC issued Order 898 to update the Uniform System of Accounts (USOA) for certain categories of assets including solar and wind generation, energy storage, environmental credits and computer hardware, software and communications equipment. The company will be creating new plant and O&M accounts for solar and wind renewable generation and energy storage as well as creation of new plant and O&M accounts within existing functions for computer software, hardware and communication equipment. The

effective date of FERC Order 898 is January 1, 2025 with prospective application required. See Exhibit A for listing of plant utility account changes for EMM and EMW. The authorized rate for the old plant utility account will be used for the assets transferred to the new plant utility account. The company will be changing from a five-digit plant utility account to a six-digit plant utility account in PowerPlant by adding a zero in the middle of the plant utility account number. For example, Plant utility Acct 31201 will be changed to 312001. If the only change was the adding of an additional zero in the middle of the plant utility account, those accounts are not listed on Exhibit A.

11. In addition to the request for authorization of depreciation rates related to the FERC changes, there are three new depreciation/amortization rates for EMM that the Company requests the authorization of a depreciation rate which are as follows: (1) since the company now maintains depreciation reserves by unit, EMM has one new location/plant account 34401 for “Hawthorn Solar”. The company proposes a 25-year life or 4.00% depreciation rate which is consistent with the new authorized rate approved S&A in Docket ER-2024-0189 for the company’s EMW Jurisdiction for the same location/plant account “Hawthorn Solar Acct 34401”. Under the new FERC rule, Account 34401 will be transferred to the new account series 338020 through 338080, (2) Intangible Account 30316 for three-year Software. The company amortizes a few software packages in this account over a three-year life or 33.33% amortization rate. The majority of software in this account currently is for a three-year agreement with Microsoft for the 2023 Microsoft Windows Enterprise Software. Under the new FERC rule, Account 30316 will be transferred to the new account 397021 and (3) Intangible Account 30317 Hawthorn Road Improvements. The company proposes amortizing over the life of the Hawthorn plant and

therefore proposes amortizing similar to the current authorized depreciation rate for Hawthorn Common Account 31100 of 3.62%.

12. The Applicant presumes that the depreciation rates established in this case will be reviewed when the Applicant submits its next depreciation study and the associated depreciation rates are authorized by the Commission.

13. Granting the DAO requested herein will not impact customer rates. Although a DAO puts the Company in a position where it can, in future rate proceedings, request depreciation expense recovery in rates, a Commission order authorizing a DAO carries with it no guarantee that such rate recovery will be allowed. The Company will seek recovery of these costs in general rate case proceedings.

WHEREFORE, for the reasons stated above, the Company requests that the Commission grant the Company's application and:

- a) issue a DAO to Applicant authorizing EMM and EMW to utilize the depreciation rates in Exhibit A related to the FERC 898 plant account changes;
- b) issue a DAO to Applicant authorizing EMM to utilize a 4.00% depreciation rate for the assets recorded in Account 34401 Other Production – Solar which will be transferred to the new plant utility account series 338020 through 338080;
- c) issue a DAO to Applicant authorizing EMM to utilize a 33.33% amortization rate for the assets recorded in Account 30316 Intangible three-year Software which will be transferred to the new plant utility account 397021;
- d) Issue a DOA to Applicant authorizing EMM to utilize a 3.62% amortization rate for the assets recorded in Account 30317 Intangible Hawthorn Road Improvements; and
- e) provide the Company such other relief that the Commission believes is

necessary and appropriate and that is not inconsistent with the DAOs requested in this application.






