ORDER CANCELLING CERTIFICATE OF SERVICE AUTHORITY

Issue Date: January 3, 2020

Effective Date: January 13, 2020

On December 19, 2019, the Staff of the Missouri Public Service Commission filed a motion requesting that the certificate of interexchange service authority and applicable tariff of Impact Telecom, Inc. be cancelled at the company's request. On December 23, 2019, the Commission issued its Order Establishing Time To Respond to Motion, which gave anyone wishing to respond to Staff's Motion, or otherwise to request a hearing, until no later than January 2, 2020, to do so. No such response or request has been filed. The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests such a hearing.¹ The Commission will cancel the certificate and accompanying tariff based upon the company's request and Staff's motion.

Commission orders take effect in thirty days unless otherwise ordered by the Commission.² This order will be made effective in 10 days to promptly implement the cancellation requested by Impact Telecom.

2. This order shall be effective on January 13, 2020.
