## ORDER CANCELING CERTIFICATE OF SERVICE AUTHORITY

Issue Date: January 3, 2020

Effective Date: January 13, 2020

On December 18, 2019, Fidelity Long Distance, Inc. filed a letter notifying the Commission that it was canceling its certificate of service authority to provide interexchange telecommunications services (IXC) services in the State of Missouri, effective immediately. Fidelity Long Distance's tariff was adopted by Fidelity Cablevision, LLC d/b/a Fidelity Communications on December 18, 2019. The Commission granted Fidelity Long Distance a certificate of service authority in File No. TA-99-468, on June 25, 1999.

The Commission's Staff filed a recommendation regarding Fidelity Long Distance's notice on January 2, 2020, indicating the notice complies with Commission rule 20 CSR 4240-28.011(3) regarding the cancellation of certificates and registrations of service authority. Staff advises the Commission to cancel Fidelity Long Distance's certificate to provide IXC service in Missouri.

The Commission has the authority to cancel a certificate of service authority pursuant to Section 392.410.5, RSMo, which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and

hearing, upon its own motion or upon application of the person or company affected.” No hearing is required because no party has requested such a hearing.<sup>1</sup>

Based on the company’s request, and Staff’s motion, the Commission finds that the certificate of service authority granted to Fidelity Long Distance shall be canceled.

Commission orders take effect in thirty days unless otherwise ordered by the Commission.<sup>2</sup> This order will be made effective in 10 days to promptly implement the cancellation requested by Fidelity Long Distance.

**THE COMMISSION ORDERS THAT:**

1. The certificate of service authority to provide interexchange telecommunications services granted to Fidelity Long Distance, Inc. in File Number TA-99-468, is canceled.
2. This order shall become effective on January 13, 2020.
3. This file may be closed on January 14, 2020.


