ORDER CANCELLING TARIFF

On November 20, 2019, Operator Service Company, LLC notified the Commission it wished to have its certificate of service authority and tariff cancelled.¹ The Commission's Staff filed a recommendation on December 2, 2019, recommending that the Commission cancel the certificate and tariff.

The Commission cancelled the certificate on December 17, 2019, but failed to cancel the corresponding tariff. The Commission will now cancel the tariff.

THE COMMISSION ORDERS THAT:

1. The tariff of Operator Service Company, LLC, Tariff No. YX-2007-0766 is cancelled.
2. This order shall be effective on January 24, 2020.
