### ORDER CANCELING REGISTRATION

Issue Date: January 8, 2025 Effective Date: January 18, 2025

On October 8, 2024, the Staff of the Commission (Staff) filed a *Motion to Cancel Certificate of Service Authority*. The Commission previously granted Fore Street Telecom, LLC registration to provide IVoIP service in File No. DA-2017-0014.

Staff's motion states that Fore Street Telecom, LLC failed to submit an annual report to the Missouri Commission for calendar years 2022 and 2023. Staff also states that Fore Street Telecom, LLC failed to file a Statement of Revenue and pay the required assessment fees for fiscal years 2024 and 2025. Staff recommended the Commission cancel the company's registration.

The Commission issued notice and allowed time to request a hearing. The company did not respond. The Commission need not hold a hearing, if, after proper notice and opportunity to intervene, no party requests such a hearing.<sup>1</sup>

Based on Staff's motion, the Commission finds that the IVoIP registration granted to Fore Street Telecom, LLC shall be canceled.
