**ORDER OPENING A REPOSITORY FILE CONCERNING STAFF'S  
REVIEW OF THE COMMISSION'S FUEL ADJUSTMENT CLAUSE  
RULES**

Provisions in the Commission's fuel adjustment clause rules<sup>1</sup> require the Commission to review the effectiveness of those rules. To assist it in reviewing the rules, the Commission would like to solicit informal comments from interested persons and companies. The Commission is opening this file to facilitate that process.

The Commission invites interested persons and companies to submit written comments and suggestions on how the effectiveness of the fuel adjustment clause rules could be improved. The Commission asks that any comments be submitted by March 1, 2011. After considering those comments, the Commission will determine whether to schedule a workshop to further address these rules. Ultimately, the Commission may proceed with a rulemaking, with an attendant formal comment procedure.
