### ORDER ESTABLISHING TIME TO RESPOND TO MOTION

On January 15, 2020, the Staff of the Missouri Public Service Commission filed a *Motion to Cancel Certificate of Service Authority*, requesting the Commission cancel Coin Phone Management Company's certificate to provide private pay telephone service.

In File No. TA-2001-323, the Commission granted Coin Phone Management Company a certificate of service authority to provide private pay telephone service in the State of Missouri.

The Commission need not hold a hearing if, after proper notice and opportunity to intervene, no party requests a hearing. Therefore, if no request for a hearing or objection to Staff's motion is received, the Commission may cancel the certificate based on Staff's motion.

The Commission finds that proper persons shall be allowed 10 days from the issuance of this order to respond to Staff's motion or request a hearing.
