## ORDER CANCELING CERTIFICATE OF SERVICE AUTHORITY

Issue Date: January 16, 2020

Effective Date: February 15, 2020

On December 18, 2019, Fidelity Networks, Inc. filed a letter purporting to cancel its certificate of service authority to provide interexchange telecommunications services (IXC) services in Missouri. The Commission's Staff responded on January 2, 2020, by filing a motion asking the Commission to cancel the certificate of service authority to provide IXC services granted to Fidelity Networks in File No. TA-2000-685 on June 1, 2000. That motion indicates Fidelity Networks' applicable tariff was adopted by Fidelity Cablevision, LLC d/b/a Fidelity Communications on December 18, 2019.

On January 3, 2020, the Commission issued an order allowing parties until January 13 to respond or request a hearing. No response was filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo (2016), which states, in part, "[a]ny certificate of service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Staff's motion and the letter from the company, the Commission finds that the certificate of service authority granted to Fidelity Networks, Inc. should be canceled.

**THE COMMISSION ORDERS THAT:**

1. The certificate of authority to provide interexchange telecommunications services granted to Fidelity Networks, Inc. in File Number TA-2000-685, is canceled.
2. This order shall become effective on February 15, 2020.
3. This file may be closed on February 16, 2020.
