ORDER DIRECTING RESPONSES TO THE CITY OF MONETT'S MOTION TO DISMISS

On January 13, 2020, the City of Monett, Missouri, filed its response to James and Denise Haston's application for a change of electrical supplier. As part of its response the City of Monett included a motion to dismiss, asserting that the Commission lacked jurisdiction because no permanent electrical service has been provided to the well house on the annexed property within 90 days prior to the annexation. The Commission will order the Ozark Electric Cooperative, Inc. and the Commission's Staff to respond to the motion to dismiss. The Hastons may also respond.

THE COMMISSION ORDERS THAT:

1. The Ozark Electric Cooperative, Inc. and the Commission's Staff are ordered to respond to the City of Monett's motion to dismiss no later than January 29, 2020.
2. If James and Denise Haston wish to respond to the City of Monett's motion to dismiss they shall do so no later than January 29, 2020.

3. This order is effective when issued.
