STAFF’S STATUS REPORT

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and states as follows:

1. On December 19, 2024, The Empire District Electric Company d/b/a Liberty (“Liberty”) and Southwest Electric Cooperative (“Southwest”) (collectively the “Joint Applicants”) filed a Joint Application to amend an existing territorial agreement (“Application”).

2. On January 2, 2025, the Commission issued its *Order Directing Notice, Setting Intervention Deadline, and Directing Staff Recommendation*, which in part set a January 23, 2025, deadline to intervene, and which set a February 3, 2025, deadline for Staff to file either a recommendation or a status report.

3. Staff submitted initial data requests (“DRs”) to Joint Applicants on January 9, 2025, and anticipates submitting additional DRs; discussion between attorneys has also occurred and may continue to further clarify information contained in the Application.

4. In order to provide sufficient time for Staff to examine Joint Applicants' request, to provide the opportunity to receive and review DR responses – and the potential need to issue additional discovery in its examination – Staff requests the Commission order Staff to submit its Recommendation no later than March 3, 2025.

5. This Status Report is made in the interest of justice and without the intent to unreasonably delay or hinder these proceedings in any manner.

WHEREFORE, Staff requests that the Commission accept this Status Report; order Staff to file its Recommendation regarding the Application no later than March 3, 2025; and to grant such other and further relief as the Commission considers just and reasonable under the circumstances.
