STAFF RECOMMENDATION TO APPROVE TARIFFS

COMES NOW the Public Service Commission Staff (“Staff”), by and through counsel, and recommends that the Commission approve the tariffs filed by Liberty Utilities (Missouri Water) LLC d/b/a Liberty.
