## ORDER CANCELING CERTIFICATE

Issue Date: January 28, 2020

Effective Date: February 7, 2020

This order cancels the private pay telephone service certificate of Coin Phone Management Company.

In Case No. TA-2001-323, the Commission granted Coin Phone Management Company a certificate of service authority to provide private pay telephone service in the state of Missouri, via customer-owned equipment.

On January 15, 2020, the Staff of the Missouri Public Service Commission filed a *Motion to Cancel Certificate of Service Authority*, requesting the Commission cancel Coin Phone Management Company's certificate to provide private pay telephone service. Staff's motion states that the company requested cancellation of its certificate of service authority.

On January 16, 2020, the Commission issued an *Order Establishing Time to Respond to Motion*, allowing responses and requests for hearing by no later than January 27, 2020. No responses were filed.

The Commission has the authority to cancel a certificate pursuant to Section 392.410.5, RSMo (2016), which states, in part, "[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected."

Based on Coin Phone Management Company's request and Staff's motion, the Commission finds the certificate granted to Coin Phone Management Company shall be canceled.

**THE COMMISSION ORDERS THAT:**

1. The private pay telephone service certificate granted to Coin Phone Management Company in Case No. TA-2001-323, is canceled.
2. This order shall become effective February 7, 2020.
3. This case may be closed on February 10, 2020.
