REQUEST FOR ADDITIONAL COMMENTS AND NOTICE OF WORKSHOP

Issue Date: January 30, 2020

The Commission opened this file on June 27, 2018, at the request of the Commission's Staff, to assist Staff in its review and consideration of a rewrite of the Commission's separate electric and gas rules regarding promotional practices into a single promotional practices rule. Several interested stakeholders have filed written comments, and a workshop was held on January 21, 2020.

On January 29, 2020, Staff filed a request asking the Commission to notify interested stakeholders that Staff would like them to file additional comments and proposed rule language by March 20, 2020. Staff also indicates it would like to reserve May 4, 2020, for a possible workshop to further discuss these matters.

The Commission will invite interested stakeholders to submit additional comments and proposed rule language by March 20, 2020. The Commission informs stakeholders that Staff has reserved May 4, 2020 for a possible workshop meeting. If such a meeting is requested, the Commission will establish the details of that meeting in a future notice.
