## ORDER GRANTING OZARK ELECTRIC COOPERATIVE ADDITIONAL TIME TO RESPOND TO THE CITY OF MONETT'S MOTION TO DISMISS

On January 13, 2020, the City of Monett, Missouri, filed a motion to dismiss James and Denise Haston's application for a change of electrical supplier, asserting that the Commission lacked jurisdiction because no permanent electrical service has been provided to the well house on the annexed property within 90 days prior to the annexation. The Commission ordered responses be filed no later than January 29, 2020, and received timely responses from the Commission's Staff and Ozark Electric Cooperative (Ozark). Ozark requested additional time to file a more comprehensive response. The Commission will grant Ozark's request.

### THE COMMISSION ORDERS THAT:

- 1. The Ozark Electric Cooperative shall file a response to the City of Monett's motion to dismiss no later than February 10, 2020.
- 2. Any party may respond to Ozark Electric Cooperative's response no later than February 14, 2020.
