On December 31, 2024, Ramey Chisum filed a complaint with the Missouri Public Service Commission against Evergy Metro, Inc. d/b/a Evergy Missouri Metro (hereinafter Evergy) pursuant to Commission Rule 20 CSR 4240-2.070. On February 7, 2025 Staff filed a request for an additional thirty-two days to file their recommendation.

On February 18, 2025, the Commission granted the request and allowed the Staff an additional thirty-two days to file a recommendation. This order is to clarify that Staff's recommendation shall be filed no later than March 11, 2025.
