NOTICE REGARDING SUBSTITUTE COMPLIANCE TARIFF

Issue Date: June 14, 2017

On June 7, 2017, the Missouri Public Service Commission (“Commission”) issued an *Order Rejecting Tariff Filing and Directing Filing*, which rejected the tariff filed by Union Electric Company d/b/a Ameren Missouri (“Ameren Missouri”) in compliance with the Commission’s Report and Order issued in this matter and directed Ameren Missouri to file a new tariff in this proceeding consistent with the language proposed by Staff in its recommendation. On June 9, 2017, Ameren Missouri filed a Motion to Substitute Tariff and a substitute tariff sheet with an effective date of June 17, 2017. The Commission has reviewed the tariff filing and will take no action regarding that tariff. The tariff will go into effect on June 17, 2017.


