On June 12, 2018, Union Electric Company d/b/a Ameren Missouri, the Staff of the Commission, Missouri Department of Economic Development-Division of Energy, Wal-Mart Stores, Inc., Missouri Industrial Energy Consumers, Wind on the Wires, Natural Resources Defense Council, Sierra Club, Renew Missouri Advocates d/b/a Renew Missouri, and the Office of the Public Counsel filed a Second Non-Unanimous Stipulation and Agreement ("Agreement") stating that the Agreement resolves all issues in this proceeding.
